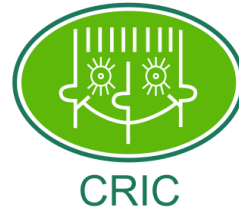

Background and results

The 2016-2020 CRIC strategy was centered on three main strategic directions:

- ◆ Strengthening systems, structures and mechanisms in order to transpose rights into reality
- ◆ Building capacities of rights holders to ask for their rights and of duty bearers to respect their obligations
- ◆ Integration of the application of the general principles of the United Nations' Convention on the Rights of the Child (CRC)

Among the main results obtained on the first strategic direction, we would like to highlight school regulations based on children's rights and annual reporting on violence in education, along with promoting the right to freedom of opinion in schools through the Student Council and the curriculum package on education for society. Among the aspects that have not advanced to the desired level are development of the National Action Plan on Parenting and the functioning of the inter-sectoral mechanism for protecting children from violence.

With regard to strengthening the capacity of rights holders to claim their rights and to duty-bearers to fulfil their obligations, the main successes of CRIC include an increase in the number of reports on discrimination, violence or neglect of children's rights, that were written with the direct participation of children, a sign that they are overcoming their fear of talking about aspects that are underdeveloped/ under-addressed. At the same time, children validate/acknowledge the behavioural changes in some of the professionals that CRIC has worked with in its capacity-building programs, a sign that behavioural change is possible and produces results if the intervention is professional and properly calibrated in duration and intensity. In the context of its membership in the APSCF (Alliance of the active NGOs in the field of Child and Family Social Protection), CRIC has been involved in strengthening the capacity of the networks' member organizations to stimulate and practice children's participation in their activities and to create opportunities for the participation of children.

Beyond the progress made, children's voices continue to be insufficiently listened to and taken into account by duty-bearers, both individually, as adults/professionals, and at institutional level. There are also professionals whose attitudes towards children's rights have not changed, despite their involvement in specific capacity-building programs, have insufficient knowledge of and willingness to assume their obligations towards

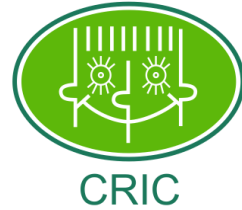
children and their rights. The failure of adults and institutions to deliver the changes they have promised to children is disappointing. Distrust in the institutional capacity to provide protection and respect for the rights of the child is hence increasing among the children whose expectations are growing, once they understand their rights.

The integration of CRC principles in normative acts and in the regulations for the organization and functioning of different institutions has progressed and CRIC has managed to create models of good practice in collaboration with non-governmental organizations (such as Diaconia) or school institutions (such as National Students' Council in vocational education and training); also, collaboration with the Office of the People's Advocate for the Rights of the Child (Children's Ombudsperson) has made significant progress, along with the child's participation program in the decision-making process. However, CRIC's capabilities are limited and there is a significant number of children that do not have access to the organization's programs, while CRIC's sustained efforts do not always seem to have identified the most appropriate way to help adults understand CRC principles correctly, as well as to comprehend the rights of the child and their responsibilities as adults or as professionals in relation to children's rights.

The CRIC team is in the process of consolidating and streamlining its manner/way of working, with clear development and consolidation objectives that will be integrated in the new strategic plan, in order to continue to act with professionalism and motivation towards continuing efforts to promote children's rights, despite the fact that the results of its work take more time to come by and that the best interests of the child are not always at the basis of the actions taken by the bearers of legal or moral obligations/duties.

In 2020, Moldova presented its first Voluntary National Review on the Implementation of the Sustainable Development Goals (SDGs). Significant progress was registered in achieving SDG 1, 8, 13 and 17, while the results obtained in achieving SDG 2, 3, 5, 7, 9 and 11 are moderate. Although efforts were undertaken to develop all the social areas, their impact on achieving the SDG 4, 6, 10, 12, 15 and 16 was to a lesser extent noticeable ([link](#) – see challenges). The implementation of CRIC's new strategy will directly contribute to the achievement of SDGs with less progress, such as SDG 4. Quality education and SDG 16. Peace, justice and strong institutions, but also to SDG 5. Gender Equality.

The context created by the Covid-19 pandemic has contributed to the exacerbation of existing inequalities, while at the same time exposing once invisible children to light. A number of children's rights have been negatively affected by the context of the pandemic, including the right to education, which is affected on the one hand by children's unequal access to equipment computers and internet connections and, on the other, by the unequal capacity of teaching staff to organize the teaching-learning process in an online context environment. A number of children were deprived of access to basic social services in the context of the closure of face-to-face service centres and access to educational and extracurricular activities delivered by non-governmental organizations. The number of victims of domestic violence increased during the quarantine period which led to the coexistence of victims with aggressors for long periods of time, and children were exposed to increased risks of abuse, violence and access to inappropriate content online. All these elements are essential in the context of the CRIC's current strategic planning, which seeks to constantly adapt to changes in society in order to provide programs and services that advance children's rights.

Typology of interventions

Directions (strands) of intervention are practical approaches aiming at achieving the goals and strategic results defined. CRIC's activity is focused on **4 specific directions (strands) of intervention/action**:

(1) Strategic partnerships	CRIC collaborates with strategic partners to promote knowledge and respect for children's rights at all levels of society
(2) Strengthening capacities	CRIC develops the individual capacities of children and adults (parents, caregivers, professionals), of civil society organizations and public institutions working with and for children to know, understand, respect and put into practice the rights of the child
(3) Innovative projects	CRIC develops, tests and shares innovative projects, intervention and support models, education and participation systems, which it then multiplies by empowering other actors to put them into practice
(4) Monitoring and reporting	CRIC monitors and reports at local, national and international level on how the rights of the child are respected in accordance with the legislation in force and the international organizations and treaties to which the Republic of Moldova is a party
